**TRADEMARK AND PATENT
SECURITY AGREEMENT**

FOR GOOD AND VALUABLE CONSIDERATION, receipt and sufficiency of which are hereby acknowledged, CLARENCE J. VENNE, L.L.C., a Delaware limited liability company (the "Grantor") with principal offices at 1425 Hanford Street, Levittown, Pennsylvania, 19057, hereby grants to Harris Trust and Savings Bank, as the Secured Party, with principal offices at 111 West Monroe Street, Chicago, Illinois 60603 (the "Grantee"), a security interest in (i) all of the Grantor's right, title and interest in and to the United States trademarks, trademark registrations and trademark applications (the "Marks") set forth on Schedule A attached hereto, (ii) all of the Grantor's right, title and interest in and to the United States patents (the "Patents") set forth on Schedule B attached hereto, in each case together with (iii) all Proceeds and Products of the foregoing (as set forth in Section 1(k) of the Security Agreement referred to below) of the Marks and Patents, (iv) the goodwill of the businesses symbolized by the Marks and (v) all causes of action arising prior to or after the date hereof for infringement of any of the Marks and Patents or unfair competition regarding the same.

THIS TRADEMARK AND PATENT SECURITY AGREEMENT (this "Grant of Security Interest") is made to secure the full and prompt performance and payment of all the Obligations of the Grantor, as such term is defined in the Security Agreement between the Grantor and the Grantee, dated as of July 6, 2001 (as amended, restated, supplemented or otherwise modified from time to time, the "Security Agreement"). Upon the occurrence of the events set forth in Section 12 of the Security Agreement, the Grantee shall, upon such satisfaction, execute, acknowledge, and deliver to the Grantor an instrument in writing releasing

the security interest in and re-assigning the Marks and Patents acquired under this Grant of Security Interest.

This Grant of Security Interest has been granted in conjunction with the security interest granted to the Grantee under the Security Agreement. The rights and remedies of the Grantee with respect to the security interest granted herein are without prejudice to, and are in addition to those set forth in the Security Agreement, all terms and provisions of which are incorporated herein by reference. In the event that any provisions of this Grant of Security Interest are deemed to conflict with the Security Agreement, the provisions of the Security Agreement shall govern.
