Pursuant to Section 251 of the General Corporation Law of the State of Delaware

RASTER GRAPHICS, INC. a Delaware corporation ("Raster"), does hereby certify as follows:

FIRST: Raster is a corporation duly organized and existing under the laws of the State of Delaware and **CYMBOLIC SCIENCES, INC.** ("Cymbolic") is a corporation duly organized and existing under the laws of the State of Delaware. Raster and Cymbolic are sometimes hereinafter referred to as the "constituent corporations".

SECOND: An Agreement and Plan of Merger (the "Merger Agreement"), dated as of December 5, 2000 between Cymbolic and Raster, setting forth the terms and conditions of the merger of Cymbolic with and into Raster (the "Merger"), has been approved, adopted, certified, executed and acknowledged by each of the constituent corporations in accordance with Section 251 of the Delaware General Corporation Law.

FOURTH: The Certificate of Incorporation of Raster, as in effect at the effective time of the Merger, shall be the Certificate of Incorporation of the Surviving Corporation from and after the effective time of the Merger, until amended as provided by law.
