

TRADEMARK ASSIGNMENT



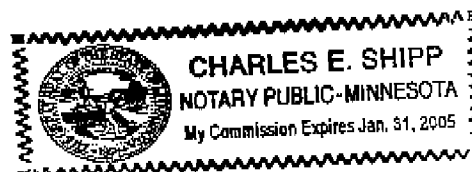
