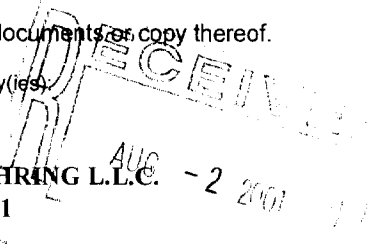

This Amended and Restated Certificate of Formation of Centeon L.L.C. (the "LLC"), dated December ~~22~~, 1999, has been duly executed and is being filed by John Bond, as an authorized person, in accordance with the provisions of 6 Del. C. § 18-208. 
