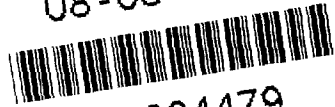

ASSIGNMENT OF MARK




