# QUITCLAIM ASSIGNMENT

This QUITCLAIM ASSIGNMENT is made by and between:

WHEREAS ASSIGNOR has been identified in the U.S. Patent and Trademark Office records as having an interest in and to the trademark LITTLE WONDER for hedge trimmers and U.S. Registration No. 152,384, therefor; and

WHEREAS, ASSIGNOR has no right, title or interest whatsoever in said trademark, said registration or the goodwill associated therewith.

WHEREAS, ASSIGNOR and ASSIGNEE desire to resolve this ownership ambiguity and insure that whatever right, title and interest in and to the LITTLE WONDER trademark, U.S. Registration No. 152,384 therefor and the goodwill associated with the mark that might be claimed by ASSIGNOR are solely owned by ASSIGNEE.

NOW, THEREFORE, in consideration of Ten Dollars (US\$10) and the mutual promises of the Parties, the sufficiency of which is acknowledged, the Parties agree as follows:

ASSIGNOR hereby sells, transfers, assigns and conveys unto ASSIGNEE and its successors and assigns forever with quitclaim covenants only all of such right, title and interest as ASSIGNOR

may hold in the trademark LITTLE WONDER for use on hedge trimmers, U.S. Registration No. 152,384 for said mark and the goodwill associated with said mark.
