ASSIGNMENT

Be it known that for good and valuable consideration, the receipt of which is hereby acknowledged, said Assignor does hereby terminate said Agreement and assign unto said Assignee, all right, title and interest in and to the Trademarks, including but not limited to the listed trademarks and trademark rights as listed on Schedule A .

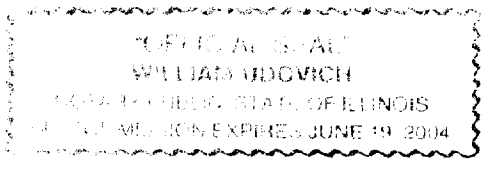
