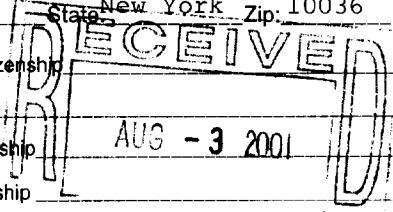


ASSIGNMENT OF TRADEMARKS
