TRADEMARK ASSIGNMENT AGREEMENT

THIS TRADEMARK ASSIGNMENT AGREEMENT ("Agreement") is made by and between Interface Solutions, Inc., a Pennsylvania corporation ("ISI"), and Interface Investments, Inc., a Delaware corporation with a registered office at 103 Springer Building, 3411 Silverside Road, Wilmington, Delaware 19801 ("Investments"), to be effective as of the 30th day of March, 2001 ("Effective Date").

BACKGROUND

ISI is the owner and current user of the trademark listed on Exhibit "A" attached hereto and all of the right, title and interest in such trademark, including, without limitation, all of the related intangible assets and goodwill associated with such trademark, and all of the damages and payments for present and future infringements thereof, royalties and all other income derived therefrom (collectively, the "Property"). ISI desires to assign and transfer to Investments, and Investments desires to obtain from ISI, all of ISI's right, title and interest in the Property as of the Effective Date as a contribution by ISI to the capital of Investments. ISI and Investments desire to confirm and acknowledge in writing hereby such assignment and transfer.

NOW, THEREFORE, the parties hereto, intending to be legally bound, agree as follows:

For good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, ISI does hereby, by these presents, convey, set over, grant, sell, transfer, assign and deliver to Investments the whole and entire right, title and interest in and to the Property (consisting of the trademark listed on Exhibit "A" attached hereto and all of the right, title and interest in such trademark, including, without limitation, all of the related intangible assets and goodwill associated with such trademark, and all of the damages and payments for present and future infringements thereof, royalties and all other income derived therefrom) as of the Effective Date. Investments, its successors and assigns, shall have and hold the Property for its own use and benefit forever.

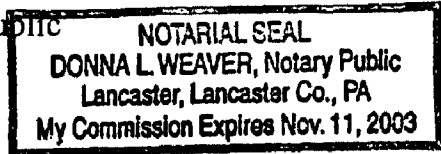
