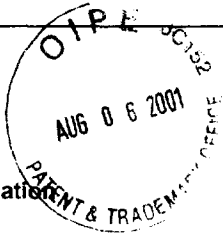

WHEREAS, this Assignment of Trademarks will effectuate that assignment;


