TRADEMARK ASSIGNMENT

WHEREAS, in light of the foregoing, the parties acknowledge that this Assignment is intended to effectuate an assignment to ASSIGNEE of all rights in and to the said Marks, the issued trademark registration, and the goodwill of the business associated with such Marks.

NOW, THEREFORE, for good and valuable consideration, receipt of which is hereby acknowledged, said ASSIGNOR does hereby assign unto the said ASSIGNEE all rights, title and interest in and to the said Marks together with the goodwill of the business symbolized by the Marks, and the issued registration thereof, as well as all rights to damages or profits, due or accrued, arising out of past infringement of such mark or injury to said goodwill and the right to sue for and recover the same in ASSIGNEE'S own name.

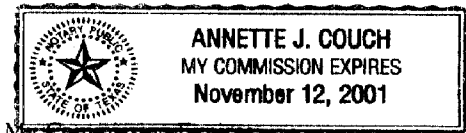
