DIRECTIONS FOR FILLING OUT TRADE NAME FORMS

1. Fill out all four trade name forms (all four are identical.) All 4 must be filled out with original signatures.
2. Print clearly and legibly.
3. Companies or small businesses can not be incorporated. Hence, the word, Inc. can not appear anywhere on the form. If you want to incorporate your business, you file with the State of New Jersey.
4. All four forms must be notarized by a Public Notary. If you are not a resident of the state of NJ, the forms are notarized on the back.
5. You are the deponent. You must sign all four forms in front of the notary. The notary notarizes on the opposite side.
6. Once all forms are completed, you must bring them to the County Clerk's office with a fee of \$32.00 cash or money order. WE DO NOT ACCEPT CHECKS FOR TRADE NAMES!
7. **IMPORTANT!!** You must check the trade name books located in the record room to ensure that no one else is using the name you wish to choose. You should really check these books before you write in the name of the business.
