



- (ii) Discal shall be the disappearing corporation upon the effective date of the merger pursuant to the provisions of the General Corporation Law of the State of California and the Corporation shall continue its existence as the

- (iii) The issued shares of Difcal shall not be converted in any manner nor shall any cash or other consideration be paid or delivered therefore, inasmuch as the Corporation is the owner of all outstanding shares of Difcal, but each such share which is issued as of the effective date of the merger shall be surrendered and extinguished.
- (iv) The Board of Directors and the proper officers of the Corporation are hereby authorized, empowered and directed to do any and all acts and things, and to make, execute, deliver, file, and/or record any and all instruments, papers and documents which shall be or become necessary, proper or convenient to carry out or put into effect any of the provisions of the merger herein provided for, and
- (v) The merger herein provided for shall become effective as provided by applicable law."


