The parties further acknowledge and agree that this agreement may not be modified, unless agreed to, in writing, by the parties.

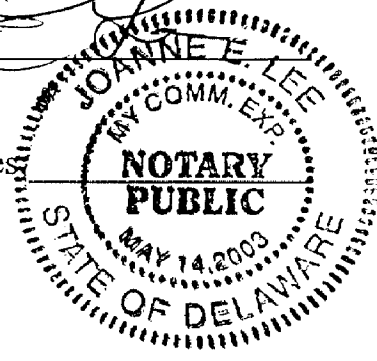

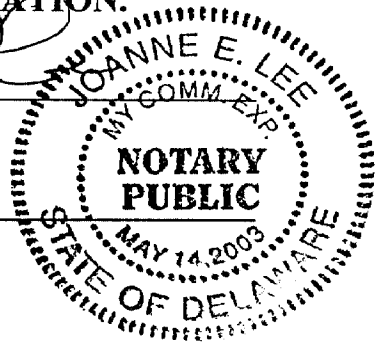
