RELEASE OF TRADEMARK SECURITY AGREEMENT

RELEASE, dated 7/11/01 granted by Bank Boston Retail Finance, Inc. ("BBRF").

WITNESSETH:

WHEREAS, Factory Card Outlet of America, Ltd. ("FCOA") and BBRF have entered into a Trademark Security Agreement, dated as of _____, (the "Trademark Security Agreement"), pursuant to which FCOA granted to BBRF a security interest in all of the Trademarks and Licenses (as such terms are defined in the Trademark Security Agreement);

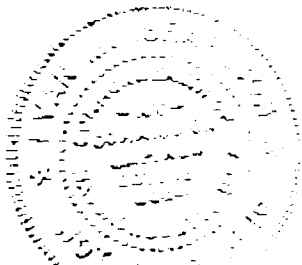
