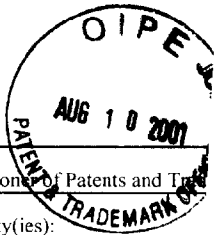

The plaintiff, Presidential Bank, FSB f/k/a Presidential Savings Bank, FSB ("Plaintiff"), by its attorneys, Certilman Balin Adler & Hyman, LLP, having duly moved this Court by Notice of Motion dated May 11, 2001; and the matter coming on before this Court on May 22, 2001; and the Motion having been served upon all of the Defendants and upon Luis F. Echeverria, Esq., counsel for the defendants, Asian-Am Product, Inc., Peter Lee and Rachanee Cheanpardee,

NOW, upon the reading and filing of the Notice of Motion dated May 11, 2001; the Affirmation of Jaspreet S. Mayall, Esq., affirmed on the 11th day of May, 2001; the Affidavit of A. Bruce Cleveland sworn to on the 11th day of May, 2001; the Summons and Complaint; the Exhibits annexed hereto, all in support of the motion; and Michael D. Brofman, Esq. of Certilman Balin Adler

& Hyman, LLP, having appearing in support of the motion; and there being no opposition thereto; and upon the record made before the Court on that day; and after due deliberation having been had; and upon the decision of the Court dated May 23, 2001;

ORDERED, that the motion is hereby granted without opposition to the extent that it is:

ORDERED AND ADJUDGED, that the Plaintiff, Presidential Bank, FSB f/ka Presidential Savings Bank, FSB, having its principal place of business at 4600 East-West Highway, Bethesda, MD 20814 shall recover of the defendants, Asian-Am Product, Inc., located at 75A Onderdonk Avenue, Ridgewood, New York 11385, Peter Lee located at 21 Crest Road, Manhasset Hills, New York 11040 and Rachanee Cheanpardee located at 21 Crest Road, Manhasset Hills, New York 11040, jointly and severally, in the amount of \$1,547,259.73 plus late charges in the amount of \$77,362.99 together with statutory interest from March 8, 2001 in the amount of \$47,308.00 and costs and disbursements of this action in the sum of \$ 602.00 for a total of \$ 1,672,532.72 on the first, second, third, sixth and seventh causes of action in the Plaintiff's Complaint' and it is further;

ORDERED, that Plaintiff's Fourth Cause of Action, for the appointment of a Receiver, the subject of a separate application, is hereby severed; and it is further
