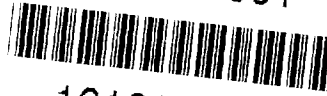

NOTICE OF SECURITY INTEREST

IN U.S. TRADEMARKS

WHEREAS, Spectel Limited, an Irish corporation (herein referred to as "Assignor"), has adopted, used and is using the trademarks listed on the annexed Schedule 2-AA, which trademarks are registered in the United States Patent and Trademark Office, or are applications pending in the United States Patent and Trademark Office (the "Trademarks");

WHEREAS, Assignor is obligated to Ulster Bank Markets Limited (herein referred to as "Assignee"), as agent for itself and for the ratable benefit of the financial institutions party from time to time to the Loan Agreement dated as of November 28, 2000(as amended, the "Loan Agreement") and has entered into a Trademark, Patent and Copyright Security Agreement dated the date hereof (the "Agreement") with Assignee; and
