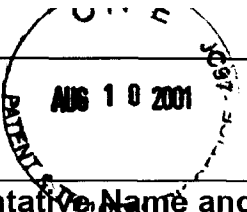

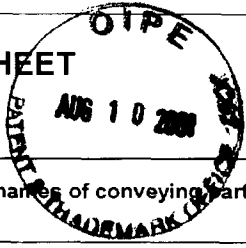

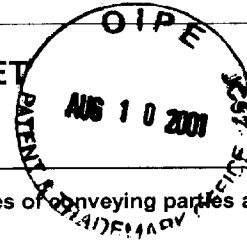

State Street Bank and Trust Company of Connecticut, National Association, as Agent for Connecticut Mutual Life Insurance Company, The Connecticut Development Authority, and Security Insurance Company of Hartford, is the recipient of a security interest in, and a continuing lien upon, certain trademarks and trademark applications more fully identified in a Commercial Revolving and Term Loan and Security Agreement dated as of April 15, 1993 among Rogers Corporation (the "Pledgor") and State Street Bank and Trust Company of Connecticut, National Association, as Agent for Connecticut Mutual Life Insurance Company, The Connecticut Development Authority, and Security Insurance Company of Hartford (the "Secured Party"). 

For valuable consideration, the receipt of which is hereby acknowledged, subject to the prior surrender and release of the trademarks listed on Schedule B, the Secured Party releases the Pledgor from the Commercial Revolving and Term Loan and Security Agreement, the continuing lien thereof, and all obligations thereunder as it relates to all of the trademarks and trademark applications listed on Schedule A, and subject to the prior surrender and release of the trademarks listed on Schedule B, the Secured Party hereby surrenders and releases any and all security interest or other interest it now or ever has had in any and all of the trademarks and trademark applications listed on said attached Schedule A, and subject to the prior surrender and release of the trademarks listed on Schedule B, surrenders and releases its security interest in, and continuing lien upon, all of the trademarks and trademark applications described in the Trademark Security Agreement filed and recorded on April 20, 1993, at Reel 0955, Frame 0372 et. seq. as it relates to all of the trademarks and trademark applications listed on Schedule A.
