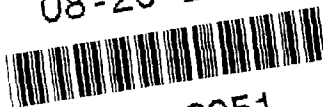

**AGREEMENT FOR
ASSIGNMENT OF TRADEMARK**

THIS AGREEMENT made and effective the 13th day of January, 2001, between Royal Precision, Inc. ("Royal"), a corporation having an address of 15170 N. Hayden Rd. Suite 1, Scottsdale, Arizona 85260, and Golfsmith International, Inc. ("Golfsmith"), a Delaware corporation having an address of 11000 North Interstate 35, Austin, Texas 78753-3195

WHEREAS, Golfsmith warrants and represents that it has acquired title of and is the sole and exclusive owner of U.S. Trademark Registration No. 1,320,963 for the mark "PRECISION LITE" for use in connection with sporting goods, namely golf clubs and the goodwill associated with that mark; and

WHEREAS, Royal seeks to acquire all right, title and interest Golfsmith has in and to the mark "PRECISION LITE " and U.S. Trademark Registration 1,320,963, along with the goodwill associated with the mark in connection with sporting goods, namely golf clubs;

THE PARTIES HEREBY AGREE AS FOLLOWS

1. Golfsmith agrees to assign and transfer to Royal all rights, title, and interest it has in and to the trademark "PRECISION LITE " and the trademark registration set forth herein, together with the goodwill of the business symbolized by the mark and the registration.
2. In consideration of the assignment and transfer, Royal shall pay to Golfsmith the sum of Five Thousand Dollars (\$5,000.00), payable in the form of credits to be issued to Golfsmith in two equal amounts of \$2,500.00 each. One \$2,500.00 credit shall be issued to Golfsmith on or before January 25, 2001, and one \$2,500.00 credit shall be issued to Golfsmith on or before April 1, 2001. Golfsmith may use such credits towards purchase of any Royal products.

3. Attached as Exhibit A is a copy of the Confirmation of Assignment for Trademark evidencing the transfer of title from Golfsmith to Royal. The assignment is subject to and dependent upon the fulfillment of the obligations of the parties expressed herein.
