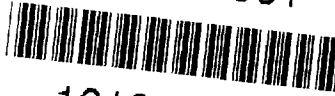


FIRST: The name of the Corporation (hereinafter sometimes referred to as the "Corporation") is:
