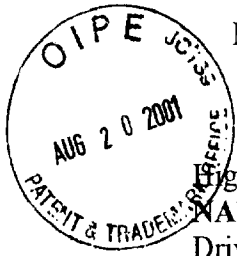

MEMORANDUM OF SECURITY INTEREST IN PATENTS AND TRADEMARKS

VENETEC INTERNATIONAL, INC., a Delaware corporation, whose address is 1255 High Bluff Drive, Suite 170, San Diego, CA 92130 ("Venetec"), does hereby grant to CITY NATIONAL BANK, a national banking association, whose address is 400 North Roxbury Drive, Beverly Hills, CA 90210, ("CNB"), pursuant to a Security Agreement dated August 2, 2001 ("Security Agreement") a security interest in and to:

(1) All of Venetec's right, title and interest in all patents and rights and interests of every kind or nature in patents and inventions protectible by patent, and all renewals and extensions thereof, including without limitation in and to (a) the patents and patent applications which are identified on Schedule I attached hereto and herein incorporated by this reference, together with any and all patents issued with respect thereto; (b) all inventions owned by Venetec based upon, incorporated in, derived from, incorporating or relating to the items identified on said schedule, together with any and all counterpart patents in the United States and worldwide and any and all improvements, patents reissues, reexaminations, extensions, continuations, continuations-in-part and divisions respecting such inventions (collectively, the "Patents");

(2) All of Venetec's right, title and interest in all trademarks and rights and interests of every kind or nature in trademarks and rights protectible by trademarks, and all renewals and extensions thereof, including without limitation in and to the trademark registrations and trademark applications for registration which are identified on Schedule II attached hereto and herein incorporated by this reference, together with any and all trademark registrations issued with respect thereto (collectively, the "Trademarks"); and

(3) All actions for past, present and future infringement concerning the foregoing, and all proceeds of the foregoing, including, without limitation, license royalties and proceeds of infringement suits.

Venetec agrees that if any person, firm or corporation shall do or perform any acts which CNB believes to constitute an infringement of any Patent or Trademark, or violate or infringe any rights of Venetec in any Patent or Trademark, or if any person, firm or corporation shall do or perform any acts which CNB believes to constitute an unauthorized or unlawful manufacture, sale or use of any invention protected by any Patent or Trademark, then and in any such event, upon, and during the continuance of an Event of Default (as defined in the Security Agreement), CNB may and shall have the right to take such steps and institute such suits or proceedings as CNB may deem advisable or necessary to prevent such acts and conduct and to secure damages and other relief by reason thereof, and generally to take such steps as may be advisable or necessary or proper for the full protection of the rights of the parties. CNB may take such steps or institute such suits or proceedings in its own name or in the name of Venetec or in the names of the parties jointly.

The terms and conditions of the security interest granted hereby are contained in the Security Agreement, between Venetec and CNB. The security interest granted hereby is as security for Venetec's performance of Venetec's obligations identified in the Security Agreement as being secured thereby. Nothing contained in this Memorandum of Security Interest in Patents and Trademarks shall be construed as an assignment of the Patents, patent applications nor as


limiting any interest which CNB may have in any other collateral described in the Security Agreement or otherwise.

Upon and during the continuance of an Event of Default as defined in the Security Agreement, CNB may exercise all rights and remedies described therein, and Venetec hereby authorizes CNB to make, constitute and appoint any officer or agent of CNB as CNB may select, in its sole discretion, as Venetec's true and lawful attorney-in-fact, with power (upon CNB's notice to Venetec of its intention to do so) to (a) enforce its security against any of the Patents and Trademarks, (b) grant or issue any exclusive or non-exclusive license under the Patents and Trademarks to anyone, or (c) assign, pledge, convey or otherwise transfer title in or dispose of the Patents and Trademarks to anyone. Venetec hereby ratifies all that such attorney shall lawfully do or cause to be done by virtue hereof. CNB shall have, in addition to all other rights and remedies given it by the terms of the Security Agreement and this Memorandum of Security Interest in Patents and Trademarks, all rights and remedies allowed by law.



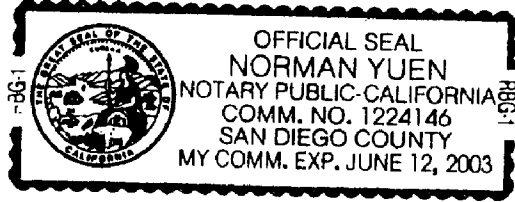
