

RELEASE OF SECURITY INTERESTS

WHEREAS, pursuant to the Patent, Trademark and License Security Agreement (“**Security Agreement**”) entered into on October 29, 1996 between Unimark, Inc., (“**Unimark**”) and Mercantile Business Credit, Inc. (“**Mercantile**”), Unimark granted a security interest to Mercantile in certain Patents, Trademarks, and Licenses (as defined in the Security Agreement), in the goodwill of Unimark’s business connected with and symbolized by the Trademarks, and in all proceeds, indemnities, warranties and guaranties, including all other forms of collateral identified in the Security Agreement (collectively the “**Secured Property**”); and

WHEREAS, such Security Agreement was recorded within the records of the United States Patent and Trademark Office at reel 1496, frames 0464-0478; and

WHEREAS, all of the obligations arising in connection with the grant of the security interest have now been satisfied and Mercantile desires to formally release its security interest and all right, title and interest of Mercantile in and to the Security Property; and

WHEREAS, pursuant to the Security Agreement, Mercantile agreed to execute and deliver to Unimark all instruments as may be necessary or proper to extinguish Mercantile’s security interests in the Patents, Trademarks, and Licenses;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Mercantile does hereby release and forever discharge and reconvey to Unimark all of Mercantile’s security interest in Unimark’s right, title, and interest in, to and under the Secured Property, including Mercantile’s security interest in the trademark registrations identified on Schedule A, attached hereto, so that it is as if the security interest had never been granted by Unimark; and Mercantile does further acknowledge and affirm that all of the rights and remedies of Mercantile with respect to the security interest and mortgage concerning the Secured Property have been and are hereby extinguished; and Mercantile further agrees to perform all additional acts necessary (including executing additional documents) to confirm that Mercantile has no interests of any type in, to, or under the Security Property.
