NUNC PRO TUNC ASSIGNMENT OF TRADEMARK

WHEREAS, as of March 6, 1998, Autocraft Industries, Inc., an Oklahoma corporation, was the owner of the trademark ZENER, along with United States Registration No. 1,885,420, dated March 21, 1995, therefor, for distributorships featuring automotive electronic products comprising cellular telephones, stereo systems, alarm systems, and engine control modules, provided to automobile manufacturers, automobile distributors and the general public; and

WHEREAS, on March 6, 1998, Autocraft Industries, Inc. (now known as The Fred Jones Companies, Inc.) sold, assigned, transferred and conveyed to Aftermarket Technology Corp. ("ACI"), a Delaware limited partnership, all of its right, title and interest in and to, and to the use of the ZENER mark and United States Registration No. 1,885,420 therefor for use on distributorships featuring automotive electronic products comprising cellular telephones, stereo systems, alarm systems, and engine control modules, provided to automobile manufacturers, automobile distributors and the general public;

NOW THEREFORE, for good and valuable consideration, the receipt of which is hereby acknowledged, said Autocraft Industries, Inc. confirms that it has sold and assigned, and does hereby sell and assign unto the said Aftermarket and ACI *nunc pro tunc* as of March 6, 1998, all of its right, title and interest in and to the said mark and the registration thereof, No. 1,885,420, together with the goodwill of the business symbolized by the mark.
