WHEREAS, Informix Corporation, a Delaware Corporation, and Informix Software, Inc., (both referred to as "Informix"), a Delaware Corporation, with a place of business at 4100 Bohannon Drive, Menlo Park, California 94025, has adopted, owns, used or is using, and is the sole owner of the entire right, title and interest, including the goodwill associated therewith, in the trademarks listed below (referred to as the "Trademarks");

WHEREAS, International Business Machines Corporation, a New York corporation, (referred to as "IBM"), is desirous of acquiring the entire right, title and interest, to the Trademarks, including the applications, registrations and common law rights, in and to the Trademarks, along with the goodwill associated therewith, for valuable consideration;

NOW, THEREFORE, for good and valuable consideration, the receipt of which is hereby acknowledged, Informix hereby transfers and assigns to IBM, its successors and assigns, free and clear of all liens or other encumbrances, (other than Permitted Liens), and IBM hereby accepts the transfer and assignment of, the entire right, title and interest of Informix in and to the Trademarks including common law rights thereof and any rights based on an intent to use such Trademarks, as indicated on the attached schedules, along with the goodwill associated therewith, in all countries and regions of the world as indicated, including the right to file applications and obtain Trademarks under the terms of any international treaty or conventions, and further agrees to perform such lawful acts and to execute any and all trademark applications, assignments, affidavits, and any other papers in connection therewith necessary to perfect such trademark rights; and all renewals and extensions thereof which may be granted relating to the Trademarks; and Informix hereby authorizes and requests the Commissioner of Patents and Trademarks to issue all further trademarks resulting from any applications pending with regard to the Trademarks, insofar as IBM's interest is concerned, to IBM as assignee of Informix's entire right, title and interest therein.

Informix also hereby transfers and assigns to IBM, its successors and assigns, and IBM hereby accepts the transfer and assignment of, any foreign rights to the Trademarks, in all countries and regions of the world, including the right to file applications and obtain trademarks under the terms of any international treaty or conventions, and further agrees to perform at IBM's expense, upon reasonable notice, such lawful acts and to execute any and all trademarks applications, assignments, affidavits, and any other papers in connection therewith necessary to perfect such trademark rights.

This Trademark Assignment is subject to and includes by reference all of the representations, warranties, covenants and indemnities of or by Informix with respect to the Intellectual Property set forth in the Master Purchase Agreement among IBM and Informix dated as of April 24, 2001 ("the MPA"). Capitalized terms used but not identified herein shall be the meanings given to such terms in the MPA.

Upon the written request of IBM, Informix hereby further agrees that Informix will sign all lawful papers, execute all renewal, extension and substitute applications, make all lawful oaths, and provide reasonable assistance to aid IBM, its successors, assigns and nominees to obtain and enforce proper protection for the Trademarks in all countries.
