ARTICLE ONE

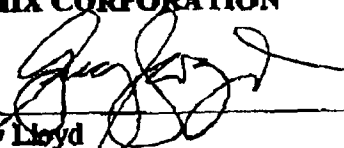
"The name of the Corporation is: Ascential Software Corporation."
