ASSUMPTION AGREEMENT, dated as of May 29, 2001, made by NatureSmart, LLC, a Colorado limited liability company, BioSmart Direct Sales, LLC, a Colorado limited liability company, and Physiologics, LLC, a Colorado limited liability company (each an "Additional Grantor"; collectively, the "Additional Grantors"), in favor of The Chase Manhattan Bank, as administrative agent (in such capacity, the "Administrative Agent") for the banks and other financial institutions or entities (the "Lenders") parties to the Credit Agreement referred to below. All capitalized terms not defined herein shall have the meaning ascribed to them in such Credit Agreement.

W I T N E S S E T H :

WHEREAS, NBTY, Inc. (the "Company"), certain of its Foreign Subsidiaries, the Lenders and the Administrative Agent have entered into a Third Amended and Restated Credit and Guarantee Agreement, dated as of April 27, 2001 (as amended, supplemented or otherwise modified from time to time, the "Credit Agreement");

WHEREAS, the Company and certain of its Subsidiaries (other than the Additional Grantors) have entered into the Amended and Restated Guarantee and Collateral Agreement, dated as of April 16, 1999 (as amended, supplemented or otherwise modified from time to time, the "Guarantee and Collateral Agreement") in favor of the Administrative Agent for the benefit of the Lenders;

WHEREAS, the Credit Agreement requires the Additional Grantors to become a party to the Guarantee and Collateral Agreement; and

WHEREAS, the Additional Grantors have agreed to execute and deliver this Assumption Agreement in order to become party to the Guarantee and Collateral Agreement;

NOW, THEREFORE, IT IS AGREED:


1. Guarantee and Collateral Agreement. By executing and delivering this Assumption Agreement, the Additional Grantors, as provided in Section 8.15 of the Guarantee and Collateral Agreement, hereby become party to the Guarantee and Collateral Agreement, each as a Grantor thereunder, with the same force and effect as if originally named therein as Grantors and, without limiting the generality of the foregoing, hereby expressly assume all obligations and liabilities of a Grantor thereunder. In furtherance of the foregoing, the Additional Grantors hereby assign and transfer to the Administrative Agent, and hereby grant to the Administrative Agent, for the ratable benefit of the Lenders, a security interest in all of the Collateral now owned or at any time hereafter acquired by each of the Additional Grantors or in which each of the Additional Grantors now have or at any time in the future may acquire any right, title or interest, as collateral security for the prompt and complete payment and performance when due (whether at the stated maturity, by acceleration or otherwise) of such Additional Grantors' Obligations. The information set forth in Annex 1-A hereto is hereby added to the information set forth in Schedules 1, 2, 3, 4, 5, 6 and 7 to the Guarantee and Collateral Agreement. The Additional Grantors hereby represent and warrant that each of the representations and warranties contained in Section 4 of the Guarantee and Collateral Agreement is true and correct on and as

the date hereof (after giving effect to this Assumption Agreement) as if made on and as of such date.


**2. GOVERNING LAW. THIS ASSUMPTION AGREEMENT SHALL BE GOVERNED BY, AND CONSTRUED AND INTERPRETED IN ACCORDANCE WITH, THE LAW OF THE STATE OF NEW YORK.**
