RELEASE OF SECURITY INTEREST IN TRADEMARKS

THIS RELEASE OF SECURITY INTEREST IN TRADEMARKS (the "Agreement") is made as of the 31st day of June, 2001, between Durango Georgia Paper Company f/k/a Gilman Paper Company, a Georgia corporation ("DURANGO" or "Assignee") and Bank of America N.A. as Administrative Agent, a national banking association (the "Assignor" or "Agent").

WHEREAS, DURANGO and Assignor entered into in connection with the Loan Agreement a Trademark Security Agreement dated as of December 17, 1999 and recorded with the United States Patent and Trademark Office on or about December 27, 1999 at Reel 2011, Frame 0976, for the purpose of securing certain obligations of DURANGO to the Secured Parties;

WHEREAS, pursuant to the Trademark Security Agreement, DURANGO granted the Agent a lien on and security interest in, *inter alia*, all of its rights, title and interest in and to all Marks, including without limitation the trademark registrations identified on Schedule A attached hereto (the "Trademark Collateral");

NOW, THEREFORE, for valuable consideration and pursuant to the terms and conditions set forth in the Trademark Security Agreement:

The Agent hereby terminates and releases its security interest in and lien on the Trademark Collateral, including without limitation, the Marks identified on Schedule A attached hereto, and the Assignor hereby assigns and transfers to DURANGO, without any representation, warranty or recourse whatsoever, the Assignor's entire right, title and interest in and to the Trademark Collateral, including without limitation the Marks listed on Schedule A attached hereto, effective as of the date set forth above.

Assignor hereby agrees to execute such further instruments and documents and perform such further acts as Assignee may deem necessary to secure to Assignee the rights herein conveyed.
