**ARTICLES OF AMENDMENT
TO ARTICLES OF INCORPORATION
OF AVT, INC., A NEW MEXICO CORPORATION**

Pursuant to the provisions of Section 53-13-4 of the New Mexico Business Corporation Act, the undersigned corporation adopts these Articles of Amendment to its Articles of Incorporation:

I.

The Name of the corporation is AVT, Inc.

II.

The following amendment to the Articles of Incorporation was adopted by the Board of Directors of the corporation as of the 15th day of January, 1993, in the manner prescribed by the New Mexico Business Corporation Act:

Article I is hereby amended to read as follows:

"ARTICLE I

The name of the corporation is Avonite, Inc."

III.

The number of shares of the corporation outstanding at the time of the adoption of said amendment by the shareholders as of the 25th day of January, 1993, was fifty, and the number of shares entitled to vote thereon was fifty; there is only one class of shares which is common stock.

IV.

The number of shares voted by the shareholders as of the 25th day of January, 1993, in favor of such amendment was fifty and no shares were voted against such amendment.
