
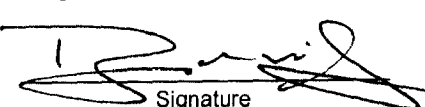

Pursuant to Sections 242 and 103 of the General Corporation Law of the State of Delaware, Thomas H. Quinn and Gregory A. Fresh hereby certify as follows:

1. That they are the President and Assistant Secretary of Beemak Holdings, Inc., a Delaware corporation (the "Company").

2. That on July 10, 1989, pursuant to Section 141(f) of the General Corporation Law of the State of Delaware, the Board of Directors of the Company duly adopted by unanimous consent the following resolution, declared its advisability and directed its submission to the shareholders for consideration and approval:

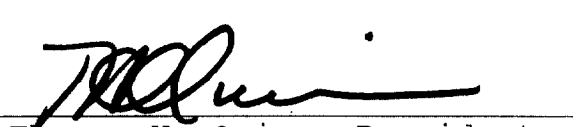
"RESOLVED, That the Certificate of Incorporation of this Company be and is hereby amended by deleting Article FIRST thereof in its entirety and by substituting for said Article the following:

BEEMAK PLASTICS, INC.'"

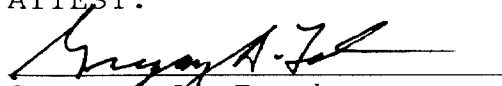
