Assignor hereby authorizes and requests the Commissioner of Patents and Trademarks to issue all Certificates of Registration issuing from applications hereunder to Assignee or its assigns.

Assignor further grants to Assignee, its successors, and assigns, the right to claim for any of said applications the full benefits and priority rights of any international agreement between the United States and any foreign country or countries or between any other countries.
