## Exhibit A

Amended and Restated  
Articles of Incorporation

The Articles of Incorporation of DataVision, Inc. are hereby amended and restated in their entirety to read as follows:

Article 1. Name. The name of the corporation is DataVision - Prologix Inc. (the "Corporation").

Article 2. Registered Office. The location and address of the registered office of the Corporation in this Commonwealth is: 539 Jacksonville Road, Warminster, PA 18974 (Bucks County).

Article 3. Business Corporation Law of 1988. The Corporation is incorporated under the provisions of the Business Corporation Law of 1988.

Article 4. Term. The term for which the Corporation is to exist is perpetual.

Article 5. Authorized Capital Stock. The Corporation shall have the authority to issue an aggregate of 10,000 shares of Common Stock, no par value.

Article 6. No Cumulative Voting. The shareholders of the Corporation shall not be entitled to cumulate their votes in the election of directors.
