**AMENDMENT TO TRANSACTION DOCUMENTS, SPECIFICALLY INCLUDING,
BUT NOT LIMITED TO, THE ASSET PURCHASE AGREEMENT**

THIS AMENDMENT (the "Amendment") is entered into by and between United States Brass Corporation, Zurn Industries, Inc., and EZ-FLO International, Inc., formerly known as Laloo International, Inc. as of February 13, 2001 and constitutes an amendment of the Transaction Documents (as defined below), including but not limited to that certain Asset Purchase Agreement entered into by and between United States Brass Corporation, Zurn Industries, Inc., and Laloo International, Inc., as of January 10, 2001 (the "Asset Purchase Agreement").

It is expressly understood and agreed that all references to "Laloo International, Inc." in the Transaction Documents shall mean "EZ-FLO International, Inc., formerly known as Laloo International, Inc." All rights and obligations of Laloo International, Inc. under the Transaction Documents shall be the rights and obligations of EZ-FLO International, Inc., successor by name change to Laloo International, Inc.

Each of the parties to this Amendment agrees to execute such other documents and perform such further acts as may be reasonably required to carry out the provisions and intent of this Amendment.

Pursuant to Section 10.5 of the Asset Purchase Agreement, this Amendment constitutes notice that Laloo International, Inc. has changed its name to EZ-FLO International, Inc.
