

U.S. Trademark Assignment

ASSIGNMENT made this 23rd day of August, 2001, by Steven Madden, Ltd., a Delaware corporation with an office and place of business at 52-16 Barnett Avenue, Long Island City, New York 11104 ("Assignor").

WHEREAS, Assignor is the owner of and has adopted the STEVIES plus Design mark covered under U.S. Application Serial Numbers 76/101945 and 76/101946 (hereinafter collectively referred to as the "Marks"); and,

Assignor warrants and represents that the Marks have not been previously assigned or encumbered in any manner and that it is free and clear of all liens and claims.

Assignor shall further render such other assistance as may be reasonably required by Assignee to record his ownership rights of the Marks in the United States.
