GENERAL ASSIGNMENT

KNOW ALL MEN BY THESE PRESENTS, that, whereas The J. M. Smucker Company, as sole shareholder of THE DICKINSON FAMILY, INC., an Oregon corporation (the "Company"), has adopted a resolution to dissolve the Company, the Company hereby grants, conveys, releases, transfers and assigns to THE J. M. SMUCKER COMPANY ("Smucker"), its successors and assigns, all of its assets, equipment, leases, contracts, trademarks, trade names and other property.

TO HAVE AND TO HOLD, such assets, equipment, leases, contracts, trademarks, trade names, and other property unto Smucker, its successors and assigns, forever. The Company, for itself and for its successors and assigns, covenants and agrees with Smucker, its successors and assigns, that (i) it has good and marketable title to its assets, equipment and other property herein transferred, free and clear of any mortgage, lien or encumbrances, except as otherwise disclosed to Smucker; (ii) that it owns the trademarks and trade names transferred by it under this General Assignment; (iii) it has authority to transfer and assign such assets, equipment, trademarks, trade names and other property to Smucker; and (iv) all of the leases and contracts of the Company are valid and subsisting and no default exists thereunder.

The Company covenants and agrees that it will


from time to time after the date of this instrument, upon the request of Smucker, do, execute, and deliver any further acts, transfers or assignments as may be required to transfer to Smucker, or to protect Smucker's right, title, and interest in, any of the assets, equipment, leases, contracts, trademarks, trade names, and other property transferred and conveyed under this General Assignment.

This instrument and the covenants and agreements contained herein shall inure to the benefit of Smucker, its successors and assigns, and shall be binding upon the Company, its successors and assigns.
