The name of the corporation is RouteMatch.com, Inc. (the "Corporation").

~~Article I of the Articles of Incorporation of the Corporation shall be amended so that~~
Article I of the Articles of Incorporation shall hereafter be and read as follows:

"I

The name of the Corporation is RouteMatch Software, Inc."

Article II of the Articles of Incorporation of the Corporation shall be amended so that
Article II of the Articles of Incorporation shall hereafter be and read as follows:

"II.

The Corporation shall have authority to issue not more than forty million (40,000,000) shares of common stock, no par value per share (the "Common Stock"), as follows: The Common Stock of the Corporation shall be divided into two (2) classes: thirty-eight million (38,000,000) shares thereof being voting Common Stock, no par value per share (the "Voting Common Stock"), and two million (2,000,000) shares thereof being non-voting Common Stock, no par value
