**CONFIRMATORY ASSIGNMENT OF TRADEMARK RIGHTS**

THIS CONFIRMATORY ASSIGNMENT OF TRADEMARK RIGHTS is made by ALPINE MEDICAL, INC., a Georgia corporation ("Alpine"), as assignor, to TELEFLEX INCORPORATED, a Delaware corporation ("Teleflex"), as assignee.

**RECITALS:**

WHEREAS, Alpine is the successor by name change to Medical Marketing Group, Inc., a Georgia corporation ("MMG"); and

WHEREAS, on February 25, 2000, Teleflex acquired the business and substantially all of the assets of MMG (the "Business Acquisition"); and

WHEREAS, MMG began using the trademark EASY CATH on and in connection with urinary catheters in the United States in 1992, and in Canada in 1993, and continued to use the trademark EASY CATH up until the Business Acquisition; and

WHEREAS, the assets and business transferred by MMG to Teleflex in connection with the Business Acquisition included the trademarks of MMG as well as the goodwill associated with the business of MMG (including, the goodwill in connection with which the trademarks were used by MMG); and

WHEREAS, Alpine and Teleflex have agreed to confirm in writing the transfer on February 25, 2000, of the trademark EASY CATH, and the associated goodwill, by MMG to Teleflex;

NOW, THEREFORE, THIS IS TO WITNESS that in consideration of good and valuable consideration previously paid to Alpine by Teleflex, the receipt of which is hereby acknowledged, Alpine confirms that it has sold, assigned and set over, and hereby does sell, assign and set over, unto Teleflex, its successors and assigns, its entire right, title and interest for, to and within the

United States, Canada and all other countries, in and to the trademark EASY CATH and the goodwill of the business in connection with which the trademark EASY CATH was used by MMG, this Confirmatory Assignment of Trademark Rights to be effective as of February 25, 2000.
