TERMINATION OF SECURITY INTEREST IN TRADEMARKS AND PATENTS

WHEREAS, Morris Rosenbloom & Co., Inc., a Delaware corporation ("Rosenbloom") having an address of 1635 Commons Parkway, Macedon, NY 14502, is the owner of the trademarks and registrations therefor (the "Marks") and the patents and registrations therefor (the "Patents") listed on Schedule A hereto and the goodwill of the business associated therewith; and

WHEREAS, pursuant to a certain Intellectual Property Security Agreement dated December 20, 2000, between Rosenbloom and General Electric Capital Corporation, a Delaware corporation ("GECC") with offices located at 83 Wooster Heights Road, Danbury, CT 06810, Rosenbloom granted to GECC a security interest in and to the Marks, the Patents, the registrations thereof, and the goodwill associated therewith; and


WHEREAS, the parties now desire to terminate GECC's security interest in the Marks and the Patents.

NOW, THEREFORE, in consideration of the foregoing and of the mutual promises and other good and valuable consideration and intending to be legally bound hereby, GECC hereby agrees as follows:

1. Effective as of the date hereof, GECC hereby releases its security interest and conveys back to Rosenbloom all of GECC's interest in and to the Marks, the Patents, the registrations thereof and the goodwill associated therewith.
2. GECC agrees to execute such statements or other documents, as may from time to time be determined to be reasonably necessary, to evidence the release of any and all liens or interests of record in the Marks and the Patents.
