RELEASE OF SECURITY INTEREST IN TRADEMARKS

Reference is hereby made to the agreement dated November 24, 1998 (the "Collateral Agreement") pursuant to which each of HARVARD INDUSTRIES, INC., a Delaware corporation, DOEHLER-JARVIS, INC., a Delaware corporation, HARVARD TRANSPORTATION CORPORATION, a Michigan corporation, DOEHLER-JARVIS GREENEVILLE, INC., a Delaware corporation, POTTSTOWN PRECISION CASTING, INC., a Delaware corporation, DOEHLER-JARVIS TECHNOLOGIES, INC., a Delaware corporation, DOEHLER-JARVIS TOLEDO INC., a Delaware corporation, HARMAN AUTOMOTIVE, INC., a Michigan corporation, HAYES-ALBION CORPORATION, a Michigan corporation, THE KINGSTON-WARREN CORPORATION, a New Hampshire corporation (collectively, the "Grantors"), granted to General Electric Capital Corporation, in its capacity as administrative agent for certain Lenders (as defined in the Collateral Agreement) ("GECC") a security interest in all of such Grantor's Collateral (as defined in the Collateral Agreement), including without limitation the following, whether presently owned or at any time hereafter acquired (collectively the "Trademark Collateral"):


- (a) (i) all trademarks, trade names, corporate names, company names, business names, fictitious business names, trade styles, service marks, logos and other source or business identifiers, and all goodwill associated therewith, now existing or hereafter adopted or acquired, all registrations and recordings thereof, and all applications in connection therewith, whether in the United States Patent and Trademark Office or in any similar office or agency of the United States, any State thereof or any other country or any political subdivision thereof, or otherwise, and all common-law rights related thereto, including without limitation any of the foregoing referred to in Schedule A, and (ii) the right to obtain all renewals thereof;
- (b) any agreement, whether written or oral, providing for the grant by or to any Grantor of any right to use any Trademark (as defined in the Collateral Agreement), including, without limitation, any of the foregoing referred to in Schedule A.

The Collateral Agreement was recorded in the United States Patent and Trademark Office on February 26, 1999 at Reel 001862 Frame 0691.


