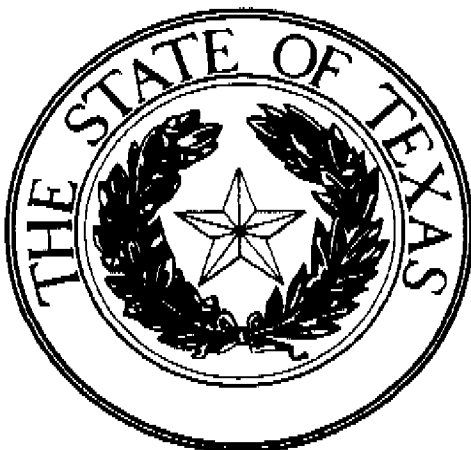

Pursuant to the provisions of Art. 4.04 of the Texas Business Corporation Act, the undersigned corporation adopts the following Articles of Amendment to the Articles of Incorporation:

**ARTICLE ONE.** The name of the corporation is Carthage Cup Company.

**ARTICLE TWO.** The following amendment to the Articles of Incorporation was adopted by the sole stockholder of the corporation on March 1, 1996:

Article One of the Articles of Incorporation is hereby amended and restated so as to read as follows:

"Article One: The name of the Corporation (hereinafter called the "Corporation") is WNA Carthage, Inc."

**ARTICLE THREE.** The number of shares of the corporation outstanding at the time of such adoption was 100; and the number of shares entitled to vote thereon was 100.

**ARTICLE FOUR.** The holders of all of the shares outstanding and entitled to vote on said amendment have signed a consent in writing adopting said amendment.
