

RELEASE AND REASSIGNMENT

THIS RELEASE AND REASSIGNMENT is executed as of ~~April~~^{May 8} ____, 2001 by FLEET CAPITAL CORPORATION, a Rhode Island corporation ("Fleet").

W I T N E S S E T H:

WHEREAS, **BJIP, INC.**, a Delaware corporation (the "Debtor") and Fleet are parties to a certain Trademark Security Agreement, dated as of September 10, 1999, pursuant to which Debtor incurred certain liabilities to and granted a security interest in and collateral assignment of the "Trademark Collateral" (as defined in the Agreement), including, without limitation, the Trademark registrations and applications for Trademark registration issued thereon or applied for in the United States or throughout the world, including registrations, recordings, supplemental registrations and pending applications for registration in the United States Trademark Office (collectively, the "Registrations") as described in Schedule A attached hereto, as security for Debtor's obligations to Fleet under the Agreement;

WHEREAS, the Agreement was submitted for recordation with the United States Trademark Office on or about September 14, 1999, and a copy of such submission is attached hereto as Exhibit 1; and

WHEREAS, Debtor has satisfied its obligations under the Agreement and has requested that Fleet release its security interest in the Trademark Collateral and reassign the same to Debtor;

NOW, THEREFORE, for good and valuable consideration, receipt and sufficiency of which are hereby acknowledged:

1. Fleet hereby releases, without any representation, warranty, or recourse whatsoever, its security interest in and collateral assignment of the Trademark Collateral.

2. Fleet hereby reassigns, grants and conveys to Debtor, without any representation, warranty, or recourse whatsoever, all of Fleet's right, title and interest, if any, in and to the Trademark Collateral, including without limitation all of the Registrations appearing in Schedule A.


