RELEASE AND REASSIGNMENT

THIS RELEASE AND REASSIGNMENT dated as of June 18, 2001, by Firststar Bank Milwaukee, N.A., through its Financial Services Division, ("Firststar")

WHEREAS, O'Bryan Bros., Inc..
