RELEASE OF SECURITY INTEREST
AND RECONVEYANCE - TRADEMARKS

WHEREAS, AAI Corporation, a Maryland corporation, with offices at York Road and Industry Lane, Hunt Valley, Maryland 21030-0126, on October 13, 1994, in a Collateral Assignment of Trademarks (the "Assignment"), assigned certain rights, title and interest, and granted a security interest, in trademarks of AAI Corporation, as described in the attached Schedule A, (the "Trademarks") to First Fidelity Bank, National Association ("First Fidelity").

WHEREAS, First Union Commercial Corporation, a North Carolina corporation, with offices at 1970 Chain Bridge Road, McLean, Virginia 22101 (the "Assignor"), is the current owner and holder of the indebtedness secured by the Assignment and has succeeded to First Fidelity's interest in and to the Trademarks.


WHEREAS, the Assignor desires to assign all rights, title and interest in the Trademarks back to AAI Corporation (the "Assignee"), and to release its rights as a mortgagee, pledgee, secured party and conditional assignee under the Assignment as to the Trademarks, and Assignee desires to acquire all right, title and interest in and to the Trademarks, including the registrations thereof and to accept the release of the security interest in the Trademarks.

NOW THEREFORE, for good and valuable consideration paid by the Assignee, receipt of which is hereby acknowledged, Assignor hereby assigns to Assignee all of Assignor's right, title and interest in and to the Trademarks, together with the goodwill of the business symbolized by the Trademarks and the right to sue and collect damages and/or profits for past infringements of the Trademarks. Further, Assignor hereby releases the mortgage, pledge, security interest and conditional assignment in and to the Trademarks, releases all other rights it may have under said Collateral Assignment of Trademarks with respect to the Trademarks, and cancels such agreement with respect to the Trademarks, effective as of the date written below.
