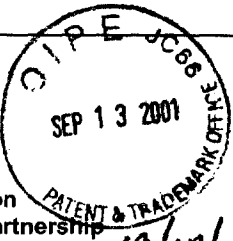

Assignee wishes to acquire from Assignor all rights, title and interest in and to the Marks, and the goodwill symbolized thereby; and


Assignor has agreed to assign the Marks to Assignee.
