**WHEREAS:**


- (1) The Assignor is either the registered proprietor or entitled to be registered as the proprietor or the applicant of the trademarks short particulars of which are set out in the Schedule (the "Trademarks"); and
- (2) Assignee is desirous of acquiring the Trademarks,

**NOW IT IS HEREBY AGREED** as follows:
