

I, Kathy A. Ahearn, Counsel and Deputy Commissioner for Legal Affairs for the New York State Education Department, hereby certify that the New School University, located in the city, county, and State of New York, was incorporated by action of the Board of Regents by the issuance of a provisional charter under the corporate name "New School for Social Research" on June 22, 1934; that such provisional charter was made absolute by Regents action on January 17, 1941; that such absolute charter was amended by Regents action on May 19, 1944, February 28, 1947 and September 24, 1976; that such corporation was consolidated by Regents action on June 22, 1984 with the Parsons School of Design, with the surviving corporation being the New School for Social Research; that the absolute charter of such consolidated corporation was amended by Regents action on September 20, 1985, July 28, 1989, April 27, 1990, September 14, 1990 and July 23, 1993; that such corporation was consolidated by Regents action on September 24, 1993 with The Mannes College of Music, with the surviving corporation being the New School for Social Research; that the absolute charter of such consolidated corporation was amended by Regents action on February 4, 1997 to change the corporate name to "New School University"; that the period for which such corporation was created is perpetual; that no certificate or order of

dissolution of such corporation has been filed or issued; and that such corporation is currently authorized to do business in the State of New York.
