BETWEEN

- (1) BASS PLC of 20 North Audley Street, London W1Y 1WE ("Bass");
- (2) HEDGES & BUTLER LIMITED of 20 North Audley Street, London W1Y 1WE ("H&B");
- (3) WINCARNIS LIMITED of 20 North Audley Street, London W1Y 1WE ("Wincarnis"); and
- (4) BASS BEERS WORLDWIDE LIMITED of Cape Hill Brewery, Birmingham, West Midlands B16 OP1 ("BBW");



of the one part, and

- (5) PETER J RUSSELL & COMPANY LIMITED, a limited company incorporated in Scotland under no. 32696 whose registered office is at Russell House, Dunnett Way, Broxburn, EH52 5BU (the "Assignee")

on the other part

RECITALS:

- (A) Under the terms of an agreement of even date between BBW and the Assignee (the "Sale and Purchase Agreement"), BBW has agreed to sell, and the Assignee has agreed to purchase the Hedges & Butler Business and the Wincarnis Business on the terms and conditions set out therein. Pursuant to the Sale and Purchase Agreement BBW has agreed to enter, and to procure that H&B, Bass and Wincarnis enter, into this Assignment;
- (B) Bass and H&B are owners of legal title to the Hedges & Butler Trade Marks specified in Part 1 of Schedule 1 and used in the Hedges & Butler Business. Wincarnis, H&B and Bass are the owners of legal title to the Wincarnis Trade Marks specified in Part 2 of Schedule 1 and used in the Wincarnis Business. BBW is beneficial owner of the Hedges & Butler and Wincarnis Trade Marks. Each of Bass, H&B, Wincarnis and BBW is hereinafter called "an Assignor".

NOW THIS ASSIGNMENT WITNESSETH as follows:-

- 1. Terms defined in the Sale and Purchase Agreement shall have the same meaning when used in this Agreement, including the Recitals.

2. In consideration of the sum of £600,000 paid by the Assignee to BBW (the receipt of which is hereby acknowledged by BBW) each Assignor (to the extent of its right, title and interest in the Trade Marks) hereby assigns unto the Assignee, its property, right, title and interest in the Trade Marks and, subject to the terms of this Assignment, the full and exclusive benefit of each of them together with that part of the goodwill of the business symbolised by and attached to the said Trade Marks, with the sum split as to £1 for the Trade Marks and £599,999 for the goodwill.
3. As soon as reasonably practicable upon receipt of written request from the Assignee, the Vendor shall sign (and procure the signature of the same by Bass International Holdings N.V. as the legal owner of the Madrid International Marks), the trademark licence in the form set out at Schedule 2.
4. The Assignor warrants to the Assignee that:
 - (a) Bass, H&B or Wincarnis, as the case may be, is the registered proprietor of the Trade Marks;
 - (b) So far as the Assignor is aware, without having made any enquiries:
 - (i) Assignor has full title to assign the Trade Marks;
 - (ii) Assignor has not granted licences to the Trade Marks;
 - (iii) there are no encumbrances (as defined in the Sale and Purchase Agreement) over the Trade Marks;
 - (iv) there are no third party claims or rights in or over the Trade Marks;
 - (c) all renewal fees in relation to the Trade Marks to the date hereof have been duly and properly paid;

but gives no other warranty or representation concerning the Trade Marks, including but not limited to use or validity.

4. The Assignee shall arrange to register assignments in the individual territories of Trade Marks and shall use reasonable endeavours to apply to record the assignments:-

CW LSR except for the Madrid International Marks, LSR CW
4.1 within twelve months where Trade Marks are in use by the Assignor in said territories at the date of the Sale and Purchase Agreement;

4.2 otherwise before Assignee commences trading under Trade Marks within those territories;

5. The Assignor shall forward all renewal notices and other correspondence it receives regarding Trade Marks forthwith to the Assignee.

6. This Assignment shall be governed by English law, and the parties submit to the non-exclusive jurisdiction of the English Courts.



- (2) **BASS BEERS WORLDWIDE LIMITED** of Cape Hill Brewery, Birmingham, West Midlands, B16 OP1 ("BBW");

(together "the Licensor")

On the one part
and

- (3) **PETER J RUSSELL & COMPANY LIMITED**, a limited company incorporated in Scotland under no. 32696 whose registered office is at Russell House, Dunnett Way, Broxburn, EH52 5BU (the "Licensee")

On the other part

RECITAL:

BIH is the registered proprietor and BBW is the beneficial owner of the international trade marks set out in the Schedule (the "Trade Marks") hereto and by an agreement of 25th September 1998 between BBW and the Licensee ("the Sale and Purchase Agreement") BBW has agreed to licence all right, title and interest in and to such marks to the Licensee and to procure that BIH joins in the Licence as registered proprietor of the Trade Marks.

NOW IT IS HEREBY AGREED as follows:

1. Terms defined in the Sale and Purchase Agreement shall have the same meaning when used in this Agreement.
2. In consideration of the Sale and Purchase Agreement Licensor hereby grants to the Licensee the irrevocable, exclusive, royalty free right in perpetuity to use

the Trade Marks in relation to the Products in the territories in which it is registered (including the right to register this Licence and to grant sub-licences).

- 3 BBW warrants to the Licensee that all renewal fees due in respect of the registration have been paid.

The Licensor shall, if requested by the Licensee bring or defend any proceedings in relation to the Trade Marks if the Licensee decides in its sole discretion to do so, provided that Licensee shall indemnify Licensor against all expenses, liabilities, costs, claims, damages, losses suffered or incurred by the Licensor as a result thereof.
- 6 This Licence shall be governed by and construed in accordance with English law and the parties submit to the non-exclusive jurisdiction of the English Courts.
