RELEASE OF ASSIGNMENT OF
TRADEMARKS FOR SECURITY

WHEREAS, by an Assignment of Security dated as of November 30, 1995, recorded in the United States Patent and Trademark Office on December 13, 1995 at Reel 1427, Frame 0728 ("Trademark Assignment"), Meenan Oil Co., L.P., a Delaware limited partnership ("Meenan") granted to Chemical Bank ("Secured Party") a security interest in and mortgage upon all right, title and interest of Meenan in and to the two trademarks listed on Schedule A annexed hereto together with, inter alia, the goodwill symbolized thereby, the registrations thereof set forth on Schedule A and all causes of action that exist by reason of infringement thereof (the "Collateral");

NOW, THEREFORE, in consideration of and in exchange for good and valuable consideration, the receipt of which is hereby acknowledged, Secured Party hereby relinquishes, releases and discharges its security interest in and its mortgage on the Collateral including the two trademarks and the registrations thereof listed on Schedule A annexed hereto.
