ASSIGNMENT OF TRADEMARKS

WHEREAS Madison Square Garden Cheering for Children Foundation, ("Assignor") with an address of Two Pennsylvania Plaza, New York, N.Y. 10121, has adopted, used, and is using the mark **NYR S.K.A.T.E. and Design**, for which the Assignor has pending application No. 76/142116 (the "Mark"); and

WHEREAS The New York Rangers Hockey Club, a division of Madison Square Garden, L.P. ("Assignee"), with an address of Two Pennsylvania Plaza, New York, N.Y. 10121, is the owner of the **NEW YORK RANGERS** trademark and the registrations thereof, including Nos. 1872469, 1662557, 1662556, 1603394, 1560478, 1567962, 0870652, 0866660, and others;

NOW, THEREFORE,

1. Assignor does hereby assign to Assignee all right, title and interest in and to the said Mark, together with the good will of the business symbolized by the Mark, and the above identified application for registration thereof.

2. Assignee shall reimburse Assignor for all the costs, including filing fees and attorney's fees, involved in the preparation and recording of this document with the United States Patent & Trademark Office.

3. Assignor agrees that Assignee shall have full and complete rights to use and maintain registrations of the Mark and Assignor shall take no action (or fail to take an action) which would diminish these rights in any way, including, but not limited to, any unlicensed use of the Mark or any use or attempt to register any trademark similar to the Mark.

4. Assignee hereby grants Assignor a royalty-free license to use the Mark only in connection with its charitable activities. All use by Assignor shall be subject to the prior approval and supervision of Assignee. This license may be terminated at any time by Assignee upon 30 days' written notice in advance of the termination date.

5. The parties agree to execute all further documentation necessary to carry out the intent of this Agreement.

6. This Agreement will be governed by the laws of the State of New York.
