# ASSIGNMENT AGREEMENT

THIS AGREEMENT is made the 12th day of March, 2001 (Two Thousand and One)

BETWEEN

FRED RAMIREZ and JESSIE R. BLASINGAME, both being United States citizens and both of P O Box 7996 Porterville, California 93258, USA (hereinafter referred to as "the Joint Assignors") of the one part

AND

JESSIE R. BLASINGAME, a United States citizen of 844 S. Westwood, Porterville, California 93257, USA (hereinafter referred to as "the Assignee") of the other part.


