THIS AGREEMENT is made the 12th day of March, 2001 (Two Thousand and One)

**BETWEEN** 

FRED RAMIREZ and JESSIE R. BLASINGAME, both being United States citizens and both of P 0 Box 7996 Porterville, California 93258, USA (hereinafter referred to as "the Joint Assignors") of the one part
